12. I agree to replace or pay for my Chromebook®, power cords and battery if they are lost or stolen.
13. I agree to return the Chromebook® and power cords in good working condition.

A protection insurance one-time fee of \$25.00 will cover accidental damages to the Chromebook if paid in advance.
